The FIRST PARTY is obligated to:

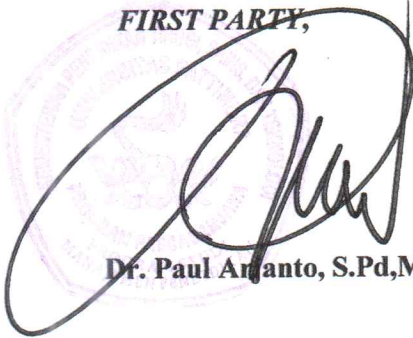
