The FIRST PARTY is obligated to:

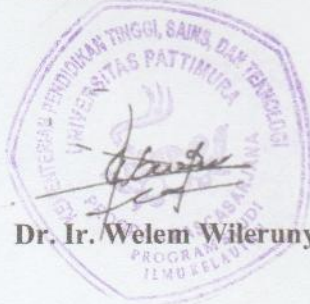

2. Share academic materials and presentations relevant to the conference theme.

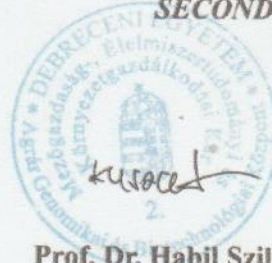
