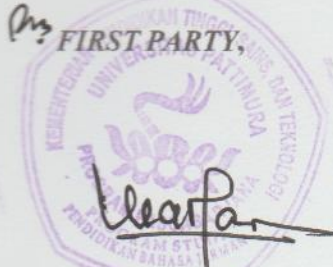
The FIRST PARTY is obligated to:

The SECOND PARTY is obligated to:

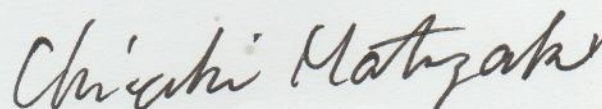
1. Serve as a keynote speaker for the First International Conference on Environmental, Agricultural, and Socioeconomic Sciences (ICESAS 2025).
